Read Aloud Board Covenant The Board	Andrew Hager
Carpet Replacement	
Put in 22 years ago, the 15-year carpet is well beyond its expected life. The A-team is getting multiple quotes, and it will come down to cost and timing. They are looking at bids both for for rooms 1 - 3 only and rooms 1 - 5 including the nursery (11-14k)	
Members of the Board recognized the need for flooring replacement but also do not want to deplete the building fund. The Building fund stands at about 23,000. Some of this money has already been earmarked for AV needs.	
The Board looked at options. One is to use funds from the reserve fund, but there is a need to be able to cover three months of payroll/expenses. The Board could change the threshold of reserves,	
Another option is to run a deficit for the year. Right now the budget is balanced.	
A third option is to ask the Congregation to borrow from the Endowment Fund, which may not be a good precedent and is not without difficulty.	
There is also the possibility of replacing some and steam cleaning the other half.	
There will be an A-team meeting Tuesday. Board will be asked to vote. Possibility of a short Zoom meeting to discuss, as needed.	
Note: the Board later approved the expenditure.	
Governance Policy

Governance involves how we organize ourselves in community  Accountability	
The members of the congregation vote for the Board of Trustees at the annual meeting, and the Board is accountable to the Congregation.	

Discussion Agenda	
The Board looks at the big picture and performs an oversight function. The Board makes major congregational decisions and has three foci: fiduciary, strategic, and generative. In this role, the Board develops goals and planning documents.	
The Ministry produces action, and includes the Minister, staff, and congregation.	
Managing/Administration, day to day, falls to the A Team. Board can direct the A-team to develop policies, but mostly the A-team deals with implementation.	
The Program Council, convened by the President-elect, creates effective programs.	
Discernment and strategy are in a zone between the A-team and the Board, working together.
