



Rules of Procedure (1 of 5)



- This Congregational Meeting of TUUC is being conducted virtually using Zoom due to health risks of gathering in person during the COVID-19 global pandemic.
- We are following the guidance of the Unitarian Universalist Association on how to conduct the meeting.
- Only Active Members may vote.
- A quorum shall be the lesser of 15% or 50 active members.
 - We currently have 222 active members, thus a quorum is 33 active members

Rules of Procedure (2 of 5)



- Absentee ballots were available through a published procedure.
- A reaffirmation of votes will happen at our next in-person congregational meeting. It's not a reconsideration of the matters, it's a confirmation of what we did in this meeting and that we consider it fine.
- The reaffirmation motion will say that the Members affirm that the votes that were taken at the meeting on 10/25/2020 were valid.
- The meeting will be recorded.

Rules of Procedure (3 of 5)



- Amendments were to be submitted in writing by September 21. No amendments will be accepted from the floor.
- The revised Bylaws will be voted on in their entirety.
- The amended and restated Articles of Incorporation will be voted on in their entirety.
- The Rules of Procedure will be voted on in their entirety.
- Each matter requires a 2/3 majority in favor to pass. Absentee ballots count toward the quorum and toward the 2/3 majority.

Rules of Procedure (4 of 5) Discussion Queues

- Members indicate a desire to speak by typing in the chat to the Discussion Queue host
 Samantha. Indicate in your chat message if you are speaking Pro or Con
- The Discussion Queue host will keep track of who wants to speak and will inform the Moderator.
- We will alternate in this fashion: Pro, Con, Pro, Con, then verbally asking if there is a phone or Chromebook participant who wishes to speak (or other person not able use the chat), then repeat.
- Please wait to be recognized. When the Moderator calls on you, start by stating your name, and if are in favor or have a concern.
- Please limit your time speaking to 2 minutes per person. We have a Time Keeper.
- Everyone should have an opportunity to speak before anyone speaks twice.
- Trustees will answer questions or comments as needed, or call on other leaders to help answer questions.
- Discussion Time Limits will be as follows: Rules of Procedure: 10 minutes; Proposed Revised Bylaws: 20 minutes; Amended and Revised Articles of Incorporation: 10 minutes.

Rules of Procedure (5 of 5): Voting



- Voting will be done using the polling feature of Zoom. Each poll will have two questions to facilitate voting by two-member households who are sharing a device. The poll will pop up on your screen.
 - If there is one Member at your location, answer question 1 with your vote (in favor, opposed, or abstention). You will answer question 2 with Not Applicable.
 - If there are two Members at your location, one person answers question 1 with your vote and one person answers question 2 with their vote.
 - The host and co-hosts will register their votes using the Yes/No feature in the participant list, since the host and co-hosts are excluded from polls.
 - Those on the phone and on Chromebooks will be invited to give their vote by voice.
 - Absentee ballots will be announced by the Board Secretary



Introduction



- This proposed Bylaws revision is the final step in a four-year effort to improve our governance
- Most of the changes were previously shared with the congregation, article by article, earlier in 2020
- Time constraints prevented these changes from coming to a vote during our June 14 annual meeting
- Since that meeting, the last of the planned changes have been incorporated. We held four listening sessions in September and received one proposed amendment by the Sept 21 deadline.
- The proposed bylaws were emailed to the congregation on Aug 28. A revision was emailed on Sept 18. The final version was emailed on October 9 and is posted in our Facebook group.

What Led to All this Focus on "Governance"?



- In 2016, the Board requested a formal assessment of our governance system. Issues and challenges at that time included:
 - Difficulty in finding a complete slate of candidates for elected leadership positions
 - Vacancies in leadership positions remaining unfilled for longer periods
 - Initiatives stalled not clear who to ask for permission; leaders assumed that they did not have the authority to proceed
 - Council Heads wondered about their purpose when committees under them didn't need oversight
 - Unclear whether the Operations Team or the Board had the authority to proceed; the resolution of conflicts that impeded progress were delayed until the annual congregational meeting

What We Found Out



- Rev. David Pyle of the UUA completed a review of our Bylaws in Oct 2016 and an assessment of our governance in Dec 2016. The findings:
 - Our bylaws were too long and too detailed
 - We had too many elected lay leadership positions for the size of our church
 - It's appropriate that leaders are accountable to the Congregation; however, our structure had most leaders reporting directly to the Congregation. This impeded progress by discouraging communication, making conflicts more difficult to resolve and making responsibilities and authority unclear.
- The Board overwhelmingly endorsed his recommendations.

What Has Already Been Done



- A Governance Task Force appointed by the Board worked to create a new governance model.
- With Congregational approval, we created two new governance structures for FY19: The Administrative Team and the Program Council. These worked within the existing Bylaws that year.
- With Congregational approval, we continued into a transition year in FY20 with the Administrative Team and the Program Council, while a new Bylaws Committee drafted a Phase I Bylaws revision: to eliminate the Operations Team.
- After listening sessions, the Congregation unanimously approved the Phase I Bylaws changes in Oct 2019.

The Current Bylaws Initiative

- After Oct 2019, the Board expanded the Bylaws Committee to work on a Phase II Bylaws revision.
- Committee Members:
 - Dan Alper, former Trustee, former member of the Gov. Task Force
 - Wendell Finner, current Treasurer, attorney (joined in May, 2020)
 - Karyn Marsh, former Trustee, former member of the Gov. Task Force, attorney, seminary graduate
 - Sue Royer, current President of the Board of Trustees
 - Herb Shankroff, former President of the Board of Trustees
 - Art Starr, former Trustee, attorney
 - Linda Talley, former President of the Board of Trustees
- This revision is now complete and includes:
 - The remainder of Rev. David Pyle's original recommendations
 - A review and changes recommended by outside attorneys with expertise in Maryland Church Law
 - Input from the Congregation and members of the Bylaws Committee
- This is the last revision associated with the initiative that began in 2016.

Summary of the most significant changes (1 of 2)

- Endowment Committee changed from elected to Board-appointed
- Endowment contribution to budget made more flexible (from 4% to up to 5% annually)
- Moderator made Board-appointed rather than an elected position
- Provision for proxy voting at Congregational Meetings
- Quorum increase at Congregational Meetings
- Provision allowing remote participation in Congregational Meetings
- Increase in Congregational majority required to approve a called Minister
- Provision allowing for the possibility of a contract Minister
- Updated language for Article 2: Purpose
- Updated pronouns to be more gender-inclusive throughout

Summary of the most significant changes (2 of 2)



- Removal of unnecessary restrictions and details on matters of policy
- Removal of references to Robert's Rules
- Rephrasing to clarify ambiguous language
- Addressed the possibility of a Trustee's removal or resignation
- Added requirement of Trustees to put the good of TUUC ahead of their own self-interest
- Membership Article simplified and added Youth Membership at age 16
- Reordering of Articles and sub-sections into a more logical sequence consistent with myriad changes
- Incorporation of advice from legal counsel



Articles of Incorporation



- Two conflicts with our Articles of Incorporation were identified through this review:
 - Date of Annual Meeting: Bylaws 4th quarter of the fiscal year, while the Articles say the month of May
 - Age required to be a Member: Bylaws age 18 (the age of majority in Maryland), while the Articles say age 21
 - Purpose is missing from our Articles
- Our original Articles of Incorporation have been amended three times. It's confusing to determine what is in effect, therefore, the attorneys suggested amending and restating them.

FOURTH: There shall be an annual business meeting of the congregation during the month of April in each year of which two weeks' notice shall be given. At such business meeting held during the month of April in the year 1961, the members of the congregation over twenty-one years of age shall, by a majority vote, elect not less than four nor more than twenty-five sober and discreet members of the congregation in good standing who are above twenty-one years of age, to serve as trustees for such terms as shall be from time to time prescribed by the By-Laws of


